Budgets comments:

- Budget is a long process, starting with a budget report book this year
- Budget preparation; consultation; decision making; analysis and reporting; presentation and then filing with Ministry of Education
- 2017-2018 budget is \$256.1 million
- Enrolment trends are watched; we are growing significantly which means additional funding
- Special Education revenue for 2016-17 was \$29.1 million and for 2017-18 it is \$30.3 million
- The board is receiving a \$2.4 million enhancement which will applied to add more staff at the elementary and secondary level
- The board has been increasing the special education staff and decreasing the special education deficit
