- 4. I will not assist others in breaking these rules or be a party to others breaking these rules.
- 5. I will not intentionally seek information about, browse, obtain copies of, or modify files or passwords, belonging to other people, whether at school or elsewhere.
- 6. I will refrain from using or introducing to the school computer environment, whether network or stand-alone, files, programs, diskettes, thumb drive / data sticks, SD cards, external hard drives, etc., known to contain viruses or malware. In this spirit, I will also regularly check my files and diskettes for viruses and endeavour to keep computing systems virus-free.
- 7. I will not try to obtain systems privileges to which I am not entitled.
- 8. I will not share my login and password with others, nor attempt to learn or use logins and passwords which are not my own.
- 9. I will not exploit any gaps in security, and furthermore will report these gaps immediately to my teacher.
- 10. At any time during my use of Internet, I am willing to explain to a supervisor or teacher my activities, and for what purpose I am accessing certain files.
- 11. If I encounter any material which is inappropriate, obscene, abusive, offensive, harassing, or illegal or which counsels illegal activities, I will report it to my teacher immediately.
- 12. The school reserves the right to review, edit or remove any material stored on school computer/network facilities.
